Dear Parent(s),

Christ's Peace be with you!

CFC-Youth is inviting your child(ren) to a Youth Camp taking place from **April 5-7, 2024**, to be held in the Emmaus House at **the Domano Renewal Centre (6500 Southridge Ave., Prince George, BC V2N 5P9)**.

The Youth Camp is the entry point to the *CFC-Youth for Christ (CFC-Y)* program of *Couples for Christ*. It is an experience that will give your child the opportunity to know and encounter Jesus Christ and build Christian friendships with other youth. This will be achieved through a program consisting of talks and sharing of personal experiences by young adults, as well as fun-filled activities utilizing the talents and skills of the participants.

*The success of this program is a collaborative effort between our ministry and you, the parents, especially in your involvement after the camp. We would like to share with parents the features of the CFC-Youth program through the Parents' Orientation scheduled on April 5, 2024, from 6:00pm to 7:00pm at the Domano Renewal Centre upon dropping your child off at the venue.*

**The camp starts with registration on Friday, April 5, 2024, at 6:00 PM and ends on Sunday, April 7, 2024 at approximately 12:00 PM.** Your child(ren) is/are asked to bring clothing for three days and two nights, including proper attire for Holy Mass. They are to bring a sleeping bag, pillow, and necessary toiletries. We ask that *all electronic devices be left at home*. If electronic devices are brought to the camp, they will be collected for safekeeping and will not be available for the duration of the weekend. *We will provide emergency contact numbers so that you are able to reach your child and vice versa if needed.*

**The camp fee of \$65 will cover complete board and lodging and camp materials. Any additional children from the same nuclear family will only be required to pay an additional \$20 camp fee per additional child. Kindly make any e-transfer payments to the noted email address below or cash directly to the CFC-Youth Couple Coordinators. Please let us know if there are any financial constraints, so we can make arrangements for your child ahead of time.** Kindly complete the attached forms, as well as the Privacy Code Waiver so we can include your child in the list of participants. Please include your email address as this is our way to send you information for future youth events. **You can return these forms to the Youth Coordinators listed below to hand in the form/payment. The due date for all forms and payment is on March 27, 2024.**

## **Couples for Christ Member Privacy Code Waiver** **(For the use of the CFC-Youth Databases and InfoSystem)**

### **What is the Couples for Christ Member Privacy Code - Canada?**

The Couples for Christ Member Privacy Code - Canada applies to all members of the organization and clearly describes Couple for Christ Ontario, Inc.'s (CFCOI) commitment and processes in compliance with PIPEDA.

### **What is PIPEDA?**

The Personal Information Protection and Electronic Documents Act (PIPEDA) came into effect in January 2001. This law protects personal information of members and provides guidelines for the collection, use, and disclosure of that information.

### **Couples for Christ Ontario, Inc. Commitment to Your Privacy**

Couples for Christ Ontario, Inc. commits to protecting your personal privacy by keeping your personal information private, accurate, and secure whenever that information is in our custody and control. The Couples for Christ Member Privacy Code - Canada outlines this commitment in detail and applies to you and your personal information.

### **What is personal information?**

Personal information is defined as information about an identifiable individual member of the Couples for Christ organization in Canada. Personal information includes all personal information except the name and service of a member; and if a full-time pastoral worker, the business address, business telephone and/or business email.

### **What can I expect from Couples for Christ, Ontario Inc.?**

- CFCOI will only collect, use, and disclose information about you that relates to your membership with the group, in order to:
  - Establish your membership to CFC-Youth
  - Greet you on your birthday
  - Be able to contact you through your email or phone number, for activities/news/invitations related to Couples for Christ and its ministries
  - Identify which of the pastoral teachings that you have not taken yet
- CFCOI will:
  - Make every reasonable effort to ensure that you have consented to the collection, use or disclosure of your information.
  - Only use or disclose your personal information for the reason it was collected unless you give us consent to use it for another reason or where permitted or required by law
  - Remove or destroy your personal information from its database when they are no longer needed for its specified purpose or legal requirements
  - Take all appropriate measures to safeguard your personal information from loss, theft, unauthorized access, disclosure, modification, or duplication.
- You may request access, in writing, to your personal information to verify its accuracy, except where prohibited by law.
- Policies and procedures are in place to investigate and respond to members' concerns and questions relating to privacy.

### **What should you do?**

Ensure that as a member of the Couples for Christ, Ontario Inc. organization, that you will comply with the Couples for Christ Privacy Code - Canada when handling your personal information and/or other members' personal information. Since you are considered a minor, you have to obtain consent from your parent(s)/legal guardian whose signature appears below.
